RULES AND REGULATIONS

- 1. Contestants must read all rules and regulations. If there any questions, please do not hesitate to ask for clarification.
- 2. Contestants must sign the **Waiver Agreement and Release of Liability** form, and complete the application form before the deadline, June 24th.
- 3. Each Contestant is required to raise a minimum of a \$1,000 (I.E. individual fundraisers, donations, pageant ticket sales, etc.) for submission by **October 7**, **2022**.
- 4. Contestants must conduct themselves in a professional manner and exhibit high moral standards at all times.
- 5. Rudeness toward judges, other contestants, pageant coordinators, etc. will not be tolerated.
- 6. Contestants will provide their own proper pageant attire. Further information on attires will be given prior to the pageant.
- 7. Contestants are also responsible for their own hair and makeup. One (1) assistant will be permitted backstage to assist each contestant.



- 8. Contestants or the parents/legal guardians must give the Pageant Organizers permission to use pageant photos for news releases, social media, etc. All photos become the property of the Metro Atlanta Alumni Chapter.
- 9. The Contestants are require to attend a "Meet & Greet" on Saturday, July 17, 2022.
- 10. The Finalist(s) will be required to participate in the Alabama State University Turkey Day Parade, Montgomery, Alabama held Thursday, November 24, 2022.
- 11. The decision of the judges are final. Contestants will be judged based on the following guidelines:
 - Written Introduction Speech **10** points
 - Formal/Evening Wear **20** points
 - Presentation, Poise, and Grooming **10** points
 - Casual/Sports Wear **20** points
 - On-Stage Question **10** points
 - Fundraiser/Donation **30** points

negligence. We understand and acknowledge that this Release Discharges

2. Insurance : I, the Guardian or adult, affirm that the
Participant is covered by primary medical insurance and understand that I am
responsible for the Participant's medical bills if injury occurs. Further, we
